Emergency shelter - provides shelter, food, clothing, medical and mental health attention, educational assistance, and transportation for youth from birth through 17 years of age who are abused, neglected, abandoned, or runaway. 150 children served, 4,091 nights of care.

4b (Code:) (Expenses \$ 470,792. including grants of \$) (Revenue \$ 547,216.) Foster care - provides for the care of children who have been removed from their home for an extended period of time and ensures their safety and well-being. Treatment foster care offers family based treatment for children with severe emotional and/or behavioral disorders that require a higher level of care. 17 children served; 701 nights of regular foster care; 2,406 nights of treatment foster care.

4c (Code:) (Expenses \$ 924,375. including grants of \$) (Revenue \$ 840,532.) Children's Advocacy Center provides comprehensive services for children and their families who are alleged victims of sexual and/or severe physical abuse in a multi-disciplinary approach to investigation. Services provided include forensic interviews, therapy and assessments, parent education, family advocacy, and case coordination. The multi-disciplinary team includes law enforcement, child protective services, prosecution, medical, and mental health providers who work jointly on these child abuse cases. The chapter supports member programs across the state with achieving accreditation through National Children's Alliance to maximize funding and assure adherence to program standards. Over 500 children served; held 375 forensic interviews in San Juan and McKinley Counties; provided 1,705 therapy and assessment
