**JOB TITLE:** Therapist – Outpatient Therapy and Therapeutic Foster Care

FLSA STATUS: Non-Exempt (Hourly)
REPORTS TO: Clinical Supervisor

**HOURS:** Full-time or part-time to accommodate child/family's schedules. Typically, Monday-Thursday

10AM - 7PM and Friday 8AM – 5PM. 1 hour lunch.

## GENERAL STATEMENT OF DUTIES:

Responsible for the overall clinical needs of clients. Provide individual, group and family counseling within the therapeutic scope of practice.

## **PRIMARY DUTIES:**

- 1. Provide therapeutic services to children, adolescents, and adults (individual, group, and family therapy) work with treatment team as needed.
- 2. Maintain timely and accurate records of counseling/ therapy sessions, Service Assessments, Treatment Plans (Review every 90 days and make appropriate changes), Social Worker updates and Discharge Summaries.
- 3. Conduct any Behavioral Health Assessments as needed/required.
- 4. Communicate with supervisors/staff regularly regarding the needs of the clients and their integration into other services.
- 5. Attend trainings/meetings, including Clinical Supervision (both one-on-one and group supervision) as required by licensure and state regulations.
- 6. Assist/train staff in crisis management.
- 7. Provide consultation to assist in resolution of client issues.
- 8. Consult with collateral services (Social Services, parents, school personnel, probation office and others) who may have knowledge of client history/needs to complete the Behavioral Health Assessment.
- 9. Make referrals via recommendations to Services Coordinator/Victim Services Specialist to needed services to assure a comprehensive wraparound & aftercare plan.
- 10. Complete paperwork in the allotted time daily to assure timely documentation, billing, and payment.
- 11. Option of working out of Farmington branch or Gallup satellite office.
- 12. Working knowledge of child development, effects of trauma on children, dynamics of child abuse, domestic violence, family dynamics, mental health diagnosis, and substance abuse.
- 13. Follow supervisor's directives and other duties as assigned.

## **QUALIFICATIONS:**

- 1. Education/Licensure and Experience:
  - a. Master's in Social Work or Counseling Psychology & Provisional NM Licensure (with eventual attainment of licensure) and experience with the target population (or)
  - b. Licensure in NM (LMSW, LCSW, LPCC, LPC, LMHC, LMFT, LPAT) and experience with the target population.
- 2. Effective oral and written communication and problem-solving skills.
- 3. Must pass local, state, and federal background checks (including fingerprints)
- 4. Must have reliable transportation and ability to become a driver for Childhaven (age 25 or older with a current and valid NM Driver's License, and a clean driving record)
- 5. Must obtain and maintain CPR/First Aid, Crisis Prevention Intervention (CPI) and Nurtured Heart Approach (NHA) certifications.
- 6. Abide by state licensing regulations and standards, and Childhaven policies and procedures.
- 7. Crisis management and de-escalation required.
- 8. Cultural awareness and sensitivity: Skilled in working with a population diverse in ethnicity, race, religion, socioeconomic background, physical and/or mental disability, sexual preference, and gender identify/expression
- 9. Documented trauma informed therapeutic training and Victim Advocacy Training (VAT) from the Crime Victim Reparation Compensation (CVRC).
  - a. Must attend at least one per year of virtual CVRC/VOCA trainings held every other month.
- 10. Familiarity with community services and social services delivery system.
- 11. Working knowledge of the DSM-V/ ICD 10.
